Use of Youth Sport Trust images and links to/from the Youth Sport Trust website

Terms and Conditions

Any Host² of a Youth Sport Trust image and/or an html link to the Youth Sport Trust web site is required to agree to:

1. The Terms and Conditions governing use of the Youth Sport Trust website and images ("the Website Terms and Conditions"), which can be accessed from the site home page.
2. The Terms and Conditions relating to hosting Youth Sport Trust images and/or any html links to the Youth Sport Trust site ("the Host Terms and Conditions"), are as follows:
 - 2.1. The Host's website must be approved by the Youth Sport Trust before use of Youth Sport Trust images and/or any html links to the Youth Sport Trust website may be displayed.
 - 2.2. The following types of sites will NOT be permitted to host Youth Sport Trust images and/or any html links to the Youth Sport Trust site: sites containing pornographic material, sites with links to pornographic sites, sites encouraging illegal activity or racism, sites providing instructions or discussions about performing illegal activities, sites engaged in libellous or harassing activities, sites that promote or utilise software or services designed to deliver unsolicited e-mail, and sites that are otherwise inappropriate in accordance with Youth Sport Trust policy from time to time.
 - 2.3. All information concerning the Youth Sport Trust must first be approved by the Youth Sport Trust in writing before it is displayed on the Host's website.
 - 2.4. The Youth Sport Trust reserves the right, in its sole discretion, to determine whether a Host's site may also display the Youth Sport Trust logo and/or any other images displayed on the Youth Sport Trust website or in any of its publications in addition to any html links from their site to the Youth Sport Trust site.
 - 2.5. The Youth Sport Trust retains ownership and all rights to the Youth Sport Trust name, logo, images and website.
 - 2.6. The Host shall indemnify and hold the Youth Sport Trust harmless from and against any and all claims, losses, liability, costs and expenses (including but not limited to legal fees) arising from the Host's breach of the Host Terms and Conditions or the Website Terms and Conditions) or the Host's website infringing any third-party rights, including but not limited to infringement of any copyright, violation of any proprietary right and invasion of any privacy rights. This obligation will survive any termination of this Agreement.
 - 2.7. The Youth Sport Trust shall be entitled to require that the Host immediately ceases to display Youth Sport Trust images and/or any html links to the Youth Sport Trust website and any other information about the Youth Sport Trust on the Hosts' website if:
 - 2.7.1. The Host breaches any of the Host Terms and Conditions or the Website Terms and Conditions.
 - 2.7.2. The Host's website contains any information which brings or is likely to bring the Youth Sport Trust's name, logos or reputation into disrepute or is contrary to the charitable objectives of the Youth Sport Trust.
3. The Youth Sport Trust shall be entitled by giving at least 30 days written notice to the Host to require that the Host ceases displaying Youth Sport Trust images and/or any html links to the Youth Sport Trust's website or any other information about the Youth Sport Trust, including the Youth Sport Trust logo, on the Host's website.

¹ The term 'Youth Sport Trust images' include all photographs, logos and any other graphic element used by the Youth Sport Trust in any Youth Sport Trust publication or on any of the Youth Sport Trust's websites.
